Designation of Operator A, Operator B, Operator C, and Operator D is for pay classification purposes and serves to group pay classifications and like equipment classifications together.

Equipment manning requirements and work rules for Operating Engineers shall be in accordance with the Project Agreement, except as modified by the following footnotes:

- 1. Operator C and Operator D may be assigned to operate up to six (6) pieces of equipment at Operator C and Operator D rates. Operator C and Operator D may be assigned to operate more than six (6) but not more than eight (8) at the B Operator rate. Operator C and Operator D may be assigned to operate more than eight (8) pieces of equipment but not more than ten (10) at A Operator rate.
- 2. Operator A and Operator B may operate up to four (4) pieces of equipment per shift in any sequence or combination.
- 3. Whenever an Operator is used in a higher classification, he shall receive the higher rate of pay.
- 4. When an Operator in a higher classification is utilized on equipment with a lower pay rate on a continuing basis, the Employer may reduce the Operator to the appropriate lower pay rate. The Operator has the option to take a lower pay rate or be subject to a Reduction in Force (RIF). The Operator shall maintain their ASD date, unless RIF'd.
- 5. When an Operator A is operating a crane with 150' or more of Main Boom, he/she shall receive a differential of \$0.30 per hour above the regular Operator A rate.
- 6. Oilers shall be utilized on all track or crawler-type cranes, rubber tired motor cranes, backhoes, shovels, clamshells, gradalls, derricks, or draglines. Oilers may be called off their regular assignments to perform other work in the immediate vicinity of the crew they are assigned to. Such assignments shall not interfere with their duties as an Oiler.
- 7. The Oiler/Driver shall be assigned to large hydraulic cranes and motor cranes during over-the-road travel only when required by the Employer.
- 8. Oilers shall not be required on hydraulic (rough terrain) cranes or farm type hydraulic backhoes.
